Team **RED** Forms for Pelotonia 2011 August Event to Raise Money for Cancer Research

Financier **RED CAPITAL GROUP, LLC**, best known for delivering comprehensive capital solutions nationwide to apartments, senior living and health care facilities, is broadening its focus this summer to help deliver capital that will eradicate cancer.



RED CAPITAL GROUP is pleased to announce the formation of the **The RED CAPITAL GROUP Peloton** (“**Team RED**”), which will participate in Pelotonia 2011, a 2-day bicycle tour held August 21-22 in Central and Southern Ohio. Although **RED** employees have ridden in Pelotonia each year, this is the first time that the firm has organized a formal team and made efforts to rally the firm’s 250 employees who wish to participate as actual and virtual riders. In addition, **RED** is uniting efforts with The ORIX Foundation, a charitable 501(c)(3) organization run by its parent ORIX USA Corporation, which will match employee contributions for the Pelotonia event.

Team **RED**’s thirteen riders will cover 1,090 miles collectively and along with 8 virtual team riders, have pledged to raise a combined goal of \$30,000 for Pelotonia. W. E. Adam Roberts, peloton captain of Team **RED** said, “*RED is excited to be supporting Pelotonia 2011! Thank you to all our family, friends, colleagues and business partners who have donated and helped in the fight against cancer.*”

The Pelotonia event, now in its third year, directly supports cancer research at the Comprehensive Cancer Center and James Cancer Hospitals/Solove Research Institute (“OSUCCC-James”) at The Ohio State University. OSUCCC-James is the Midwest’s first and Ohio’s only freestanding cancer hospital and is a national leader in creating and testing new therapies based on scientific research, many of which are offered nowhere else in the world. Again, 100% of all funds raised by Pelotonia directly support cancer research, whether through awarding fellowships and resources to medical and postdoctoral students pursuing promising, new research or supporting the production of a cancer vaccine to be used in clinical trials. There is but one goal to Pelotonia – to create a cancer-free world.
